06/23/2021 South Central Region 8 Workforce Board, Inc. Meeting

The meeting will be called to order at 12:00 Noon and adjourn by 1:30 PM. This meeting is the fourth meeting of the Program Year 2020 (July 1, 2020 to June 30, 2021). These briefs are intended to provide some background on the agenda items. Items marked with an <u>asterisk* and italics</u> require board action.

Welcome and Call to Order – Brenda Reetz, Board Chair will call the meeting to order.

<u>Approval of 02/24/2021 Meeting Minutes*</u> - The Board last met in February. The minutes of that meeting have been provided. Please read the minutes and let us know of any corrections that should be made.

<u>Financial Report and Budget*</u> - Our fiscal agent, Carla Crowe/Lauren Markley, will present the financial report for the current period. The Revenue/Expense and Grant Breakdown/Current Standing of Remaining Funds reports will be provided to Board members. We will discuss changes to the budget for the period July 1, 2020 to June 30, 2021. Fiscal Agent will also discuss contracts to be awarded to Vincennes University.

<u>Program Year 2021 Allocations</u>* - Lauren Markley will discuss allocation of carry-in funds and new allocation funds to Vincennes University from PY'20 to Py'21. <u>The Board will vote on the authorization of carry-in and new allocation funds to Vincennes University</u>.*
